- Cancellation and abandonment of tours, festivals, shows and events of every description including sporting events, theatrical productions, product launches and the like
- Non-Appearance cover for specific artists, bands, key speakers, musicians caused by death, injury; illness or incapacity of a single individual or a band, group or orchestra or any persons whose non-appearance can give rise to a claim

## General perils that can be included for cancellation, abandonment or non-appearance include:

- Power failure
- Damage to leased or rented venue
- Inability to erect facilities at venue (Denial of Access)
- Damage to surrounding venues or infrastructure
- Disease outbreak (certain exclusions may apply) resulting in lack of access
- Labour Disputes/Strikes
- Failure of public transport facilities or denial of access
- Failure of TV broadcast
- Natural catastrophes such as earthquake and flood
- Unavoidable travel delays
- Any other previously unforeseen cause not excluded
- Adverse weather conditions for outdoor events/shows
- Terrorism

## We can also provide cover for the following:

- Adverse weather for events, film shoots and the like
- Over redemption for product launches/advertising promotions
- Prize Indemnity including Hole in One; usually cover is taken for the person or company that is giving the prize should it actually be won
- Relegation/Failure cover; usually for sports teams to cover when they suffer a loss of income due to relegation or failure to achieve certain targets
